OFFICIAL RULES & REGULATIONS

1. DATES

The Contest will begin on May 1, 2019. The Contest will end at 12 AM PST on September, 30, 2019 (the "Closing Date"). One winner will be selected after the Closing Date. The winner will be selected at random from all of the eligible entries. The winner will be notified via e-mail on October 5, 2019.

2. ELIGIBILITY

The contest is open to any Canadian or American resident over the age of 18 years who enters the Contest by following the clues announced on May 1, 2019. No entry form required.

Participants agree to follow all park rules and stay on designated trails.

Misrepresentation of age or residency will disqualify the submission. The following person(s) are NOT eligible to win the contest: (a) employees of the Mill Bay Marine Group and it's marina's and restaurants, contractors, agents and/or representatives of the Mill Bay Marine Group; (b) members of the immediate family (defined as a mother, father, brothers, sisters, sons, daughters and husband or wife), or any person with whom they are domiciled, of any individual described in (a) and; (c) anyone residing in a jurisdiction in which contests of this nature are prohibited.
